
ORDER

THIS MATTER being opened to the Court by defendants by way of motion and plaintiffs by way of cross-motion, and for good cause and exceptional circumstances having been shown;

IT IS on this 24<sup>th</sup> day of October, 2016 ordered as follows:

1. The PSE&G defendants shall comply with item number one of the July 28th, 2016 notice to produce regarding the contractor safety program documents by October 28, 2016;
2. The PSE&G defendants shall produce for deposition Courtney Russell, Jose O'Barrio and the person most knowledgeable in October of 2012 of the PSE&G contractor safety program. The parties shall attempt to work together to schedule these depositions promptly. If they cannot be agreed upon, then they shall take place by notice pursuant to the Court Rules; *to be identified by Defendant on or before 10/28/16*
3. Plaintiff Renato Sousa shall attend the defense medical exam on October 27, 2016. Plaintiff may have a third party representative present who made video and audio record the exam in a non-unobtrusive manner; *no later than 11/18/16*
4. Plaintiff shall serve its liability expert report by December 20, 2016;
5. Defendant shall serve its expert report by January 20, 2017;
6. Expert depositions shall be complete by February 20, 2017;
7. The discovery end date is March 6, 2017;
8. The parties may supplement or amend expert reports pursuant to the Rules of Court;
9. The trial date of March 13, 2017 shall be rescheduled to an agreed-upon date in April. The parties are to report to the Civil assignment office by November 1, 2016 with the agreed upon April date; *April 10, 2017*
10. The above referenced motions heard by the Court on October 24, 2016, including the defendants' motion to compel the defense medical exam of the plaintiff and to extend discovery, and the cross motion of the plaintiff for discovery relief and/or to deem PSE&G defendants negligent are granted in part and denied ~~in part~~ consistent with this order. *in part*
