**ORDER TO SHOW CAUSE WITH
TEMPORARY RESTRAINTS**

THIS MATTER having come before the Court by way of the application for an Order To Show Cause, seeking temporary restraints, filed by Plaintiff, Mateus Gontijo, by and through his attorneys, Lynch ♦ Martin; the Court having considered the Verified Complaint, brief and supporting papers submitted in support thereof; and for good and sufficient cause shown;

IT IS on this _____ day of August, 2004;

ORDERED that **RONALDO J. MARTINS; BRAZIL TRAVEL; EZ-TECH SOLUTIONS; CELI ZARRATE** show cause before the Superior Court of New Jersey, Chancery Division, Monmouth County, Monmouth County Courthouse, Hall of Records, 1 East Main Street, Courtroom number 315, Freehold, New Jersey 07728, on the _____ day of _____, 2004 at _____ o'clock (a.m.) (p.m.) as to why the following relief should not be granted:

permanently freezing any assets held by defendants **RONALDO JOSE MARTINS; ANDREA CARLA MARTINS; BRAZIL TRAVEL** in excess of \$5000 pending final resolution of this litigation, both individually and in any corporate form, including but not limited to enjoining the sale of a real estate

property known as 378 West Columbus Avenue, Long Branch, New Jersey, Lot 9, Block 263 on the Long Branch Tax Map pending further order of this Court;

IT IS FURTHER ORDERED that defendants **RONALDO JOSE MARTINS; ANDREA CARLA MARTINS; BRAZIL TRAVEL** be and hereby are immediately temporarily enjoined and restrained from selling, transferring or otherwise liquidating any assets in excess of \$5000.00 (five thousand dollars), including but not limited to the sale of a real estate property known as 378 West Columbus Avenue, Long Branch, New Jersey, Lot 9, Block 263 on the Long Branch Tax Map, pending further order of this Court;

IT IS FURTHER ORDERED, that defendants **RONALDO JOSE MARTINS; ANDREA CARLA MARTINS; BRAZIL TRAVEL** shall, upon receipt of this order, serve a copy of same, together with the Verified Complaint, upon any and all prospective or actual buyers of any real estate held by defendants **RONALDO JOSE MARTINS; ANDREA CARLA MARTINS; and/or BRAZIL TRAVEL**, including but not limited to any prospective or actual buyers of a real estate property known as 378 West Columbus Avenue, Long Branch, New Jersey, Lot 9, Block 263 on the Long Branch Tax Map;

IT IS FURTHER ORDERED, pursuant to New Jersey Rules of Court, that a copy of this Order, Verified Complaint (and any other pleadings) shall be served upon any and all interested parties, personally or by mailing same to his or her last known address via certified mail, return receipt requested, as well as regular mail, within _____ days from the receipt of this Order.

IT IS FURTHER ORDERED that any interested person who desires to be heard in this action shall, no later than _____ days before the hearing date, serve upon counsel for the proponent and file with this Court such interested person's Answer and/or opposing brief and

certification. This action may proceed ex parte with respect to all interested persons so defaulting.
